The Eleventh Annual Art on the Riverfront Show is accepting applications for unique and original works of art. This is a juried event. Please read the entry procedure carefully. Return the completed entry form with your slides/photos, and check by **April 1, 2011**.

This is a fundraising event for the Grand Haven Area Arts Council. The council is a 501(c)3 non-profit, volunteer-driven organization. The Council's mission is to enhance, enlighten, and preserve the arts and culture in Northwest Ottawa County.

Application Criteria:

- Only original artwork by the accepted artist may be displayed in the booth.
- Artist must be present with his/her work for the duration of the show.
- Booth space is at least 10'x10', no stakes are allowed.
- Submit no less than 3 photos/slides of artist's work and 1 picture/slide of a fully stocked booth display. CDs with jpgs are also acceptable.
- Cost is \$75 for GHAAC Members and \$85 for Non-Members. Corner booths are an additional \$20. Waterfront booths are an additional \$20. Double, Corner and Waterfront booth space will be offered to accepted artists based on postmarked date of application. **DO NOT SEND ADDITIONAL FEES AT TIME OF APPLICATION.**
- A Self Addressed Stamped Envelope is required.
- Deadline for application is postmarked **April 1, 2011**.
- The jury selection and notification will be completed by **May 6, 2011**.
- This is a fundraising event for the Grand Haven Area Arts Council. Each artist is required to donate a piece of art for a silent auction (min. value \$25)
- **Prizes: Best in Show \$300, Second Place \$200, People's Choice \$100**
- This is a rain or shine show. No provisions or alternate dates are made in case of poor weather.
- (Optional) Choose an image (image only, no text) or include an additional image to enter into our 2011 GHAAC Art on the Riverfront Poster Contest (Clearly label the image). You must have the original artwork or at least a quality image of at least 300dpi available for use by the GHAAC. You will be notified with your acceptance letter if your image has been selected. The 2011 Art on the Riverfront Committee reserves the right to alter the final image or to reject all submissions for the final poster design. All submissions become the property of the 2011 GHAAC Art on the Riverfront Show and may be used for promotional/commercial purposes.
